Membership Agreement

This Membership Agreement ("Agreement") is made and entered into by and between the United World Blockchain Organization NPIO ("UWBO") and the Member ("Member"). By joining UWBO, the Member agrees to the following terms and conditions:

1. Membership Eligibility

- 1.1 Membership in UWBO is open to individuals, companies, and organizations that meet the eligibility criteria as determined by UWBO.
- 1.2 Each prospective member must pass an interview to verify their eligibility.

2. Membership Benefits

- 2.1 Members will have access to the following benefits:

- 6.3 INT tokens are burned upon submission of a proposal to prevent spam and encourage meaningful contributions.

7. Termination of Membership

- 7.1 Membership can be terminated by either party with written notice.
- 7.2 UWBO reserves the right to terminate membership for violations of the Code of Conduct or any other breach of this Agreement.

8. Liability and Indemnity
